Remind those that the board meets monthly.
 - o Mitzi suggested that the brick is more valuable than some of the stuff we have, so we could consider making more room for it in the storage area.
 - One stack of brick we have belonged (at lease one time) to Joe Patrick (from the Irish Times failed wall)
 - We should strive to keep 400-500 brick on hand for local projects each summer.
