- Treasurer's report report for last month \$150 donations, plus Salvage plus others
  - Exp 122.57; accnts payable, 113k Butte Historical Trust, plus SARTA committment and 15k CPR pledge.
  - We really need D2D for income this year approx. \$7k net
  - 2021 Budget review postponed until next meeting when proposed budget is available.
- Council of Commissioners meetings : Blue Range demolition
  - Tomorrow's meeting Hoffman sent letter to Butte Silverbow website; interpreted as an appeal; request chairman, Cindy Shaw, to suspend the rules to demolish Blue Range Cribs
  - However, there may be a credible buyer for only the cribs, which would need a survey;
- URA meeting: board members are referred to minutes sent earlier.
- HPC meeting at next meeting First Tuesday of March
  - 2 more demolitions -1) Daly and near Lexington corner, on register, but highly modified (not a big concern) and 2) Thriftway near Utah and Front had a trinket shop, wanted for parking. Utah building is brick with commercial front; across the alley are other vacant lots/ parking areas in immediate vicinity.
  - These recent requests likely signal continuing pressure to not stand in way of economy.
  - 2505 State St. on the flats intends to appeal HPC demolition delay at council meeting ASAP
- Website Mitzi says the current person is not doing much, but will be asking Cassie Scheidecker to take over. or possibly Emma Cunneen.. Web master at Library also a possibility.
- Membership update; Maggie sent ~35 postcards to remind members to continue their support; a few responses; Mail chimp works well
