Dust to Dazzle is back!

The Butte Citizens for Preservation and Revitalization's "Dust to Dazzle" homes tour is scheduled for Saturday June 26, 2021.

The annual event showcases recent and in-progress renovation projects in historic Butte. The tour provides an opportunity to view several structures in varying stages of renovation.

The tour has grown in popularity over the years and attracts hundreds of people, many from out of the area. Last year (2020) the tour was cancelled because of the Coronavirus risk for our community. This year, with the Butte Silver Bow County Health Department's approval, Dust To Dazzle will resume without the traditional tea, however, plans include a silent auction.

During the tour, property owners are present to explain their renovation process, problems encountered and motivations. Butte CPR volunteers serve as guides providing additional information. A short history of each building and its National Register significance is also available.

The tours are sponsored in part by area vendors whose products and services are used in the projects. Vendors are on hand to speak with attendees and provide more information.

State and local historic preservation organizations are also represented, including representatives of the Butte Silver Bow Historic Preservation Commission to answer questions about the county's Historic Preservation Ordinance, associated guidelines and tax incentives.

Tickets are available for the tour which is one of Butte CPR's main fundraisers. Proceeds benefit many projects, most notably its Historic Improvement Project fund.

While the funds raised are a welcome assist, the principal reasons for the tour are to inspire people to purchase and restore historic buildings in Butte and show what great results can be achieved while bringing a historic building back from the brink.




